

**PARENTAL CONSENT FOR MINOR CHILD**  
**INDEMNIFICATION AGREEMENT WITH WAIVER OF LIABILITY**

**THIS RELEASE AFFECTS THE RIGHT OF YOU AND YOUR CHILD TO SUE**

\_\_\_\_\_ (hereinafter “the minor”) acknowledge the inherent hazardous nature of participating in the BC Army Reserve Soldier For A Day Work Program including the possibility of personal injury including death or damage to personal property. The BC Army Reserve Soldier For A Day Work Program may include the minor’s participation in a range of BC Army Reserve activities that involves inherent risks of death, permanent serious injury, and other injury beyond those normally encountered in civilian life. *I, on behalf of the minor, myself, my dependents, my parent(s)/guardian(s), and my or their heirs, devisees, successors, assigns, executors and administrators, in consideration of the minor being permitted to participate in the BC Army Reserve Soldier For A Day Work Program on the 17<sup>th</sup> day of November 2018 in Victoria, BC do hereby covenant and agree:*

- a. to at all times indemnify and save harmless Her Majesty the Queen in Right of Canada, Her officers, servants, agents, employees and members of Her Canadian Armed Forces and/or the Department of National Defence and the Government of Canada, from and against all claims and demands, loss, costs, damages, actions, causes of action, suits or other proceedings by whomever made, brought, or prosecuted, related to any loss, property damage, personal injury or death, resulting from, occasioned by or attributable in any way to the minor’s participation in the BC Army Reserve Soldier For A Day Work Program;
- b. to waive all claims by or on behalf of the minor of any nature or kind whether in contract, tort, negligence or otherwise, against Her Majesty the Queen in Right of Canada, Her officers, servants, agents, employees and members of Her Canadian Armed Forces and/or the Department of National Defence and the Government of Canada, all in their employment and private capacities, in any manner arising out of, based upon, occasioned by or attributable to the materiel or activities of them, or any action taken or things done or maintained by virtue thereof;
- c. the minor will comply at all times with every direction given by or under the authority of Department of National Defence personnel pertaining to the minor’s participation in the BC Army Reserve Soldier For A Day Work Program, including but not limited to every written or printed direction which may be handed out from time to time or any printed notice, direction, rule, regulation or order displayed;
- d. that the minor or I on behalf of the minor will not commence or maintain against any person, any action or proceeding which will give rise to a claim against Her Majesty the Queen in Right of Canada, Her officers, servants, agents, employees and members of Her Canadian Armed Forces and/or the Department of National Defence including the BC Army Reserve and the Government of Canada, for contribution or indemnity;
- f. that the minor does not suffer from or have symptoms of any medical condition or related condition, whether acute or chronic and including but not limited to allergies, cardiovascular conditions, pregnancy or diabetic conditions which would have caused an

ordinarily prudent person to seek treatment or medication for said condition prior to the minor's participation;

- g. that if the minor suffers from or has symptoms of any medical condition or related condition that I have consulted the minor's physician regarding the minor's proposed participation in the BC Army Reserve Soldier For A Day Work Program and that the minor's physician has satisfied me that any said medical condition or related condition would not prevent the minor from participating in the BC Army Reserve Soldier For A Day Work Program, and/or that the minor has received such treatment, medication or medical follow-up as directed and/or required by the minor's physician prior to their participation;
- h. that the minor is not under the effect or influence of alcohol or drugs, including prescription drugs, that could adversely affect the minor's participation in the BC Army Reserve Soldier For A Day Work Program, and/or could contribute to the risk of injury to the minor or others, and/or could contribute to damage to the minor's personal property and/or the property of others, including the property of Her Majesty in Right of Canada; and
- i. that I acknowledge having read this indemnification agreement and liability waiver and voluntarily assume any risks associated with the minor's participation in the **BC Army Reserve Soldier For A Day Work Program on the 17th day of November 2018 in Victoria, BC** by indicating my acceptance of this document by my signature.
